SECTION 10.0 PACHECO STORMWATER DISTRICT FLOOD CONTROL AND WATER CONSERVATION SERVICE

10.1 Overview

The Pacheco Stormwater District is an independent special district formed pursuant to the Storm Water District Act of 1909. Although the District is no longer active, it continues to receive a small increment of property tax revenue each year and has cash reserves that are generating some interest income. For example, in FY 2003/2004, the District received \$382 in property tax revenue and \$393 in interest income. In FY 2004/2005, the District received \$354 in property tax revenue and \$480 in interest income. No expenses were reported in either year.

This District should be dissolved and the revenue reallocated to other taxing entities within the respective tax rate areas.

10.2 Determinations

10.2.1 Growth and Population

Purpose: To evaluate service needs based upon existing and anticipated growth patterns and population projections.
